The Hospital/SHCO can apply for any maturity level of accreditation depending on the self-assessment of the digital processes. To have a smooth application process, NABH has provided a user friendly Self-Assessment Toolkit (SAT) and an online application portal for the application of Digital Health Accreditation Program. NABH invites applications from all accredited Hospitals and SHCOs for this new accreditation program. NABH Digital Health Accreditation Program will ensure that these standards are implemented by the organization for providing patient care services through the assessment of digital processes in the healthcare organization.

To encourage HCOs/SHCOs to embark on the journey of quality digital health, NABH has announced "Early Adopters" program for the first 100 achievers of digital Health accreditation. You may refer to the benefits announced for Early Adopter Hospitals which includes 2 years subsidy of 50% across the tariff in application and accreditation fee.
